



Media and Law



Litigation



The traditional career path is to "practice law" in the courts. But it is essential for any fresh graduate to learn the ropes under a Senior Counsel. The graduates are now supposed to qualify a Bar Exam before they join the Courts of Law. Litigation provides a wide range of employment options in both private and public spheres. You may specialize in a particular field of law such as Taxation, Constitution, Family, etc. You can choose to focus on appellate work, trial-level practice, civil litigation or criminal cases.

Corporate Counsel



• You may work with a company/corporate entity as an in-house legal counsel, advising on legal matters related to its business. An in-house counsel plays an important role in drafting, vetting and negotiating contracts; ensuring and monitoring compliance with rules and laws; and handling legal disputes.

• Private Sphere: One may join Multi National Corporations, Private companies, Private Banks, etc.

•Public Sphere: Counsels are also required in Government Agencies, Public Sector Undertakings, Public and Nationalized banks, etc. These government organizations usually recruit lawyers through a written competitive exam followed by an interview.



Law Firms

•These are business entities engaged in the practice of law. A noticeable trend that has emerged in the last few years is to shift from solo practice to well organized law firms, which comprise several lawyers working together as one entity. As part of a law firm, one advises clients about their legal rights and recourses as well as other legal matters



WHY LAW?

It's the time of year when board examinations are over or about to end. This is the time when students are haunted by the confusion prevailing over the various fields which they should opt for after finishing school. Be it preliminary choice post matriculation or final step towards building their career post intermediate examinations. Gone are the days when the choices were confined to engineering and medical. With the establishment of NLUs and five year integrated law programme, it has become the first choice for thousands of youngsters.

Prior to 2008, every law school in country conducted its own entrance exam. Thereafter, the direction of Supreme Court of India to conduct an integrated exam for entrance to various national law schools, resulted into the formation of CLAT – Common Law Admission Test on the lines of CAT – Common Admission Test for Indian Institute of Management (IIM's) or IIT – JEE for Indian Institute of Technology (IIT's).

At present there are 18 Law schools under CLAT and also some of the NLUs conduct their own nationwide entrance exam. With the envision of NLU or National Law University in every state of India, the popularity of National Law Schools are day by day increasing and forming a league of its own.

Coming back to the question why law? Legal education is not just about being buried under piles of books, case laws and Latin maxims. It is way more than that. A good legal education empowers the individual unlike any other discipline; it inculcates

personal autonomy, intellectual bent of mind and development of critical life skills beyond the reach of any other discipline. Some of the great personalities who changed the world, like Abraham Lincoln, Barrack Obama and Mahatma Gandhi, chose the legal field. In today's era, where information is freely exchanged, it won't be hard to come across the realities behind the career options. All of us must be aware that in the gloomy days of global recession the demand for doctors and lawyers never decline.
